Established in 1919, IGC is a semi-private 18-hole golf course nestled along Amber Lake in Fairmont, MN. Originally IGC was designed by America's most prolific golf course architect Thomas Bendelow as a 9-hole course, and later expanded in the 1960s by renowned Minnesota designer Don Herfort.

MEMBERSHIP OPTIONS

I hereby apply for the following Membership at Interlaken Golf Club.

Family Membership - Regular - \$2,050

Family Membership - Young (age 21-29) - \$950

Family memberships allow full golf and social privileges for a married couple/co-habitants, all children living in the home up to age 18, and all children that are full-time students up to age 22.

Couples Membership - \$1,880

Couple memberships allow full golf and social privileges for married couples/co-habitants.

Individual Membership - Regular - \$1,770

Individual Membership - Senior (age 70+) - \$1,550

Individual Membership - Young (age 22-29) - \$850

Individual memberships allow full golf privileges to the member. They also allow full social privileges to the member's spouse and children.

Junior Membership (age 18 and younger) - \$150

Student Membership (age 18-21) - \$200

Student memberships allow college students whose parents are not members of IGC to play golf. However, tee times available to student members are restricted.

Social Membership - \$550

Social memberships allow limited golf privileges, full social privileges, and 4 full rounds of golf (or Eight 9-hole rounds) with cart are included.

Authorization for Payment of Fees - Electronic Bank Draft or Credit/Debit Card

I authorize Interlaken Golf Club and the financial institution or credit card company named above to deduct the amount of my monthly fee from the account identified above. I understand my automatic payment will be deducted on the first day of each month. Changes in bank account or credit card information must be submitted by completing a new Membership application form and filling out the payment information section. Changes must be received by the last day of the month in order to be processed for next month's payment. Canceling a bank draft or credit card does not cancel a membership. In the event that a bank draft is revoked, or an account is closed, and new bank or credit card information is not received, the membership fee can be paid by check. Account balances due to the Club shall be payable no later than 30 days following the statement date. If any payment is not received within 90 days of the due date, the applicant hereby authorizes the Club to charge the amount due, plus any applicable fees or penalties, to the credit card listed on the account. Early termination will only be accepted in the event of a member who passed away or a member who has accepted a military assignment out of the area.

Memberships may be canceled by the member by submitting a formal request of cancellation or resignation and will be honored under the following terms: The form is completed and received a minimum of 30 days prior to requested cancellation date. If a membership is canceled and a renewal of the membership requested within the same calendar year, Interlaken Golf Club, Inc reserves the right to initiate a review of the new membership, decline it, or, in case of approval, member understands a new initiation fee will apply. Interlaken Golf Club may at any time cancel, modify or change any membership costs and/or privileges upon written 30-day notice mailed to the last known address of the member. Any notice sent by Interlaken Golf Club, Inc is calculated from the earlier of the date the notice is mailed or received in-person.

WAIVER / RELEASE

I hereby agree to participate and/or engage in the use of the course, equipment, facilities and programs offered by the Club upon the understanding and agreement that:

1. I am aware of the risks of illness or injury inherent in any golf or exercise activity. These injury risks include but are not limited to: being hit by golf balls, golf clubs, golf carts, or lightning; stepping or tripping in holes or other natural indentations in the ground; injury from insects, animals, birds or snakes, drowning; pulled muscles or other sprains, strains or injuries. I am participating in the Club's programs upon the express understanding that I hereby indemnify, defend, waive and release the Club, its employees, agents, officers, Directors, Successors, and Assigns from any and all claims, costs, liabilities, expenses or judgments, including attorney's fees and court costs (hereafter referred to as the "Claims") arising out of my participation and the participation of my family and guests in the program(s) or any illness or injury resulting there from, and hereby agree to indemnify and hold harmless the Club from and against any and all such Claims defend, indemnify and hold harmless.

2. Interlaken Golf Club, Inc golf course and facilities will be maintained to allow for normal golf activities. There is no guarantee as to the condition of the course or any amenity included in this membership. Members will have access to amenities listed in this agreement subject to availability, which is to be determined at the sole discretion of Interlaken Golf Club. Certain private and public events may dictate that the golf course, practice areas, restaurant and/or other areas of Interlaken Golf Club, Inc be closed. Member understands and agrees that nothing in this Membership Agreement shall entitle member to any of the facilities on any particular day nor to any discount or refund on account of any limited access. Member further understands that access to the course, practice facility and the restaurant and other privileges and benefits may be limited by Interlaken Golf Club, Inc as necessary. No member is entitled to a refund or return of amounts due to damage to or condition of the golf course or any amenity. Further, Interlaken Golf Club, Inc shall have no liability for temporary suspension of any privilege due to maintenance, repair, construction, improvements, acts of God, inclement weather, utility disruptions or any and all other matters beyond control of Interlaken Golf Club Inc.

MISCELLANEOUS PROVISIONS

Entire Agreement: This Membership Agreement constitutes the full and entire Agreement between the Parties hereto and such Parties acknowledge that there is no other Agreement, oral and/or written, between the Parties hereto.

Severability: Should any term, provision, covenant and/or condition of this Membership, or any clause of part thereof, be held by a court of competent jurisdiction to be invalid, illegal, void or unenforceable, it shall be deleted from this Membership Agreement, and the balance of the Membership Agreement shall remain in full force and effect and shall in no way be affected, impaired or invalidated. Assignment: The member's rights, privileges or interests under this Membership Agreement are not assignable or transferable. However, Interlaken Golf Club, Inc may assign its interest in this Membership Agreement, and the liability of the assignor shall be terminated as to events occurring after assignment.

Modifications: This Membership Agreement may be amended or modified only by a writing signed by the Member and the golf course manager. Counterparts: This Membership Agreement may be executed in counterparts with the same effect as if all original signatures were placed on one document and all of which together shall be one and the same Agreement.
